TERMS OF PARTICIPATION / DECLARATION OF CONSENT

- The submitted weights and height, Kup and Dan are in accordance with the registration form. The main referee has the right to suspect misrepresentations directly before the competitor starts in the respective category of size and height. Deviations can lead to the immediate disqualification of the competitor from the tournament and are imposed by the main referee.
- Each competitor must be able to prove to the organizers and referees on request before and during the tournament with a valid identification document. Without proof of identity, participation will be denied and the competitor disqualified. Registration fees are **non-refundable**.
- Participants, coaches, caregivers and accompanying persons under the influence of alcohol and / or drugs are immediately disqualified and are turned away from the tournament. The disqualification will be done by the main referee or organizer. Registration fees are **non-refundable**.
- Accident and health insurance is the responsibility of the competitor, as well as liability insurance for damage to third parties or property.
- For the Suisse Taekwondo Union, compliance with the applicable data protection regulations is a matter of course. The information received from the competitor will in principle not be disclosed to third parties and will only be used to carry out SwissOpen 2018.
